Probable Cause

On March 21st, 2023, I received a call from Dep. Psinas regarding some information he had received from one of his students at East Bay K-8 about a possible school shooting at Holley Navarre Middle School. Dep. Psinas stated the student specifically saw the words "school shooting" and the initials "HNMS" which is commonly used for Holley Navarre Middle School on a social media post from

Jackson Jones.

I spoke to students from my school HNMS and was able to obtain two screenshots of Jackson's Snapchat post containing threats. Jackson's snapchat was identified through one of the students as "jjthealcoholic". The student stated she screenshotted a former student of HNMS Jackson Jones Snapchat story. The screen shots were a meme that shows a brain, with the brain saying, "reach for the officer's gun" and underneath was a caption which said, "me every time i see school security." The second one shows an individual with a shaved head holding a HI-C drink, the message on this meme was " I'm feeling so silly I might shoot up a building full of people" next to the message was several emojis, with several of them being smiling emojis.

One of the students, Sephora Felan, advised Jackson told her on discord and snapchat he was going to shoot up HNMS. Sephora advised her snapchat name was Sephorahtsu.

I was able to identify Jackson Jones as Jackson Jacob Jones (DOB 10-23-2009). It should be noted that Jackson was a former student of Holley Navarre Middle School and was recently withdrawn from the school to attend homeschooling.

A student from Woodlawn Beach Middle School reported to the school resource officer she saw the same snapchats from Jackson. She further added she was told from a friend, Jackson planned on shooting up the school this past Thursday (the one before spring break) but there were too many things going on, so he postponed it. Jackson said it was postponed until a week from Friday (3/31/23).

On March 23rd, 2023, Deputy Berry spoke to Jackson Jones about the memes from his Snapchat account. Jackson [REDACTED] Dep. Berry asked if he had any intentions of carrying any of this out and he replied "no"

A search warrant for Jackson's Snapchat (jjthealcoholic) was applied for and signed by Judge Hillard. The search warrant return shows messages and pictures from February 1, 2023 to March 23, 2023. It should be noted Snapchat uses a name to id the account to other people (jjtheacoholic) and the actual username (gabe_itch22861).

There were 3 pictures found in the return that pertain to this case. The following are a brief description and picture file names:

Also found in the return were the below chat messages from Jackson to other Snapchat accounts. (These are in no particular order by time stamp):

- Line 1824 Feb 9th "Does your plug have access to guns" (From gabe_itch22861 to shlohriver2021)
- Line 3228 Feb 9th "I want to shoot up the school" (From gabe_itch22861 to sephorahrtsu)
- Line 3173 Feb 12th "If I get a gun I'm gonna shoot up hnms lol" (From gabe_itch22861 to sephorahrtsu)
- Line 3172 Feb 12th "Not like I have access to one anyway" (From gabe_itch22861 to sephorahrtsu)
- Line 3169 Feb 12th "I'm getting a wrath and natural selection shirt so maybe but I don't think many ppl know what the columbine shooters look like :/" (From gabe_itch22861 to sephorahrtsu)
- Line 3167 Feb 12th "I always keep a knife on me so maybe I'll just stab ppl idk" (From gabe_itch22861 to sephorahrtsu)
- Line 3165 Feb 12th "Nah if I do kill people I'll just kill myself" (From gabe_itch22861 to sephorahrtsu)
- Line 3159 Feb 12th "Okay so it's been like 3-4 weeks since I got on my new on my new antidepressants and they aren't working but they're suppose to by now so I have no hope in getting better so why not kill the losers at school" (From gabe_itch22861 to sephorahrtsu)

Based on the information above, I determined Jackson Jones did willfully violate FSS 836.10 Written or electronic threats to kill, do bodily injury, or conduct a mass shooting or an act of terrorism; punishment; exemption from liability. I am respectfully requesting a warrant/capias on Jackson Jones.
